◇ Expiry date of certification.

- BST, ART (excluding single rescue) and EFA expire for two years.
 - If a refresher course is taken within two months of expiry, the next expiry date is two years from the day after the first expiry date.
 - If the refresher course is taken before two months of the expiry date, the next expiry date is two years from the date of completion of the training.
- Please note that late arrivals and early departures may not be allowed to complete the course.

◇ Documents to be submitted.

- Health condition self-assessment form (A signed PDF file must be submitted by e-mail after application. Please bring the original copy with you on the first day of training.)
- Agreement for GWO training (You will be asked to sign the form on the day of the training.)
- Consent for handling of personal information (You will be asked to sign on the day of the training.)

◇ What to bring on the day.

- Original copy of your health status self-declaration form.
- Driver's license, passport, or other ID that has your photo on it.
- Comfortable clothing and your own safety shoes and safety gloves.
- Helmets and safety glasses can be borrowed. For helmets, only EN-compliant helmets can be brought in.
- Full harnesses, lanyards, work positioning ropes and other fall prevention and restraint equipment will be provided by the training facility.
- [Sea Survival participants]swimming costume, a shirt that can get wet and a bath towel.
Please prepare cases for glasses or contact lenses if necessary.
※You will be required to wear this under your drysuit during training. Swimwear must be brought from the first day. The order in which modules are conducted may be changed from the originally scheduled timetable due to weather effects or other factors.
- Lunch will be provided. If you have food allergies or dietary restrictions, please prepare your lunch by yourself. If so, please let us know by replying booking confirmation email from us.
You can freely use our refrigerator for your lunch.
Please note that there are no convenience stores near the training facility.
- Drinking water is provided free of charge. There are also vending machines available for a fee.

◇ Cancellation fee.

◇ Cancellation of trainings due to unforeseen circumstances.

- If the training has to be cancelled due to natural disasters or infectious diseases, every effort will be made to notify the cancellation at the earliest possible stage. We cannot guarantee any costs (travel, transfer costs, etc.) due to extra nights or changes in means of transport as a result of the cancellation.
- If the training is cancelled, you will be asked to make up the course on another day or, if you cannot make up the course, the course fee will be refunded.
- Each module of GWO training must be completed within a maximum of 28 days from the start of the module. If the participant needs to leave the training while the module is ongoing due to some participant's reason and cannot reschedule for an alternative date (within 28 days from the start of the course) which is indicated by Nagasaki Ocean Academy Training, certification of that module will not be issued, and the module fee will not be refunded.
